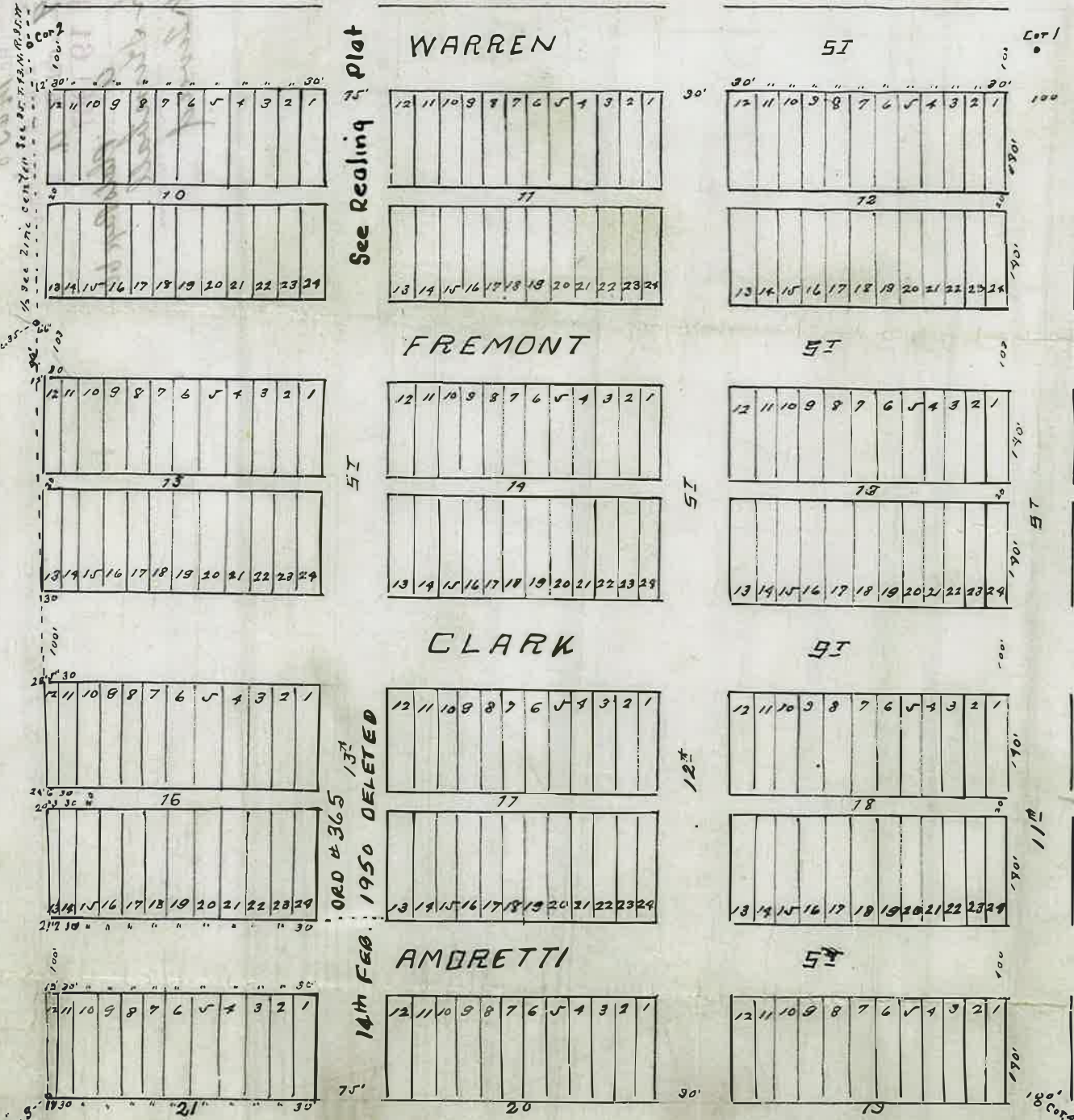


MAP OF THE KINNEY SECOND ADDITION TO THE TOWN OF THERMOPOLIS Wyoming

W. 404 ft. to 1/4 corner on south side of said section 35. Thence south 1/2 section line through Section 2, T. 42. N. R. 95. W. 986 ft. to north side of alley in block 21, on corner 3. Thence east 1320 ft. to center of 11th Street, on corner 4. Thence 720 ft. to corner No. 1, on place of beginning. A. D. Lopez surveyor
