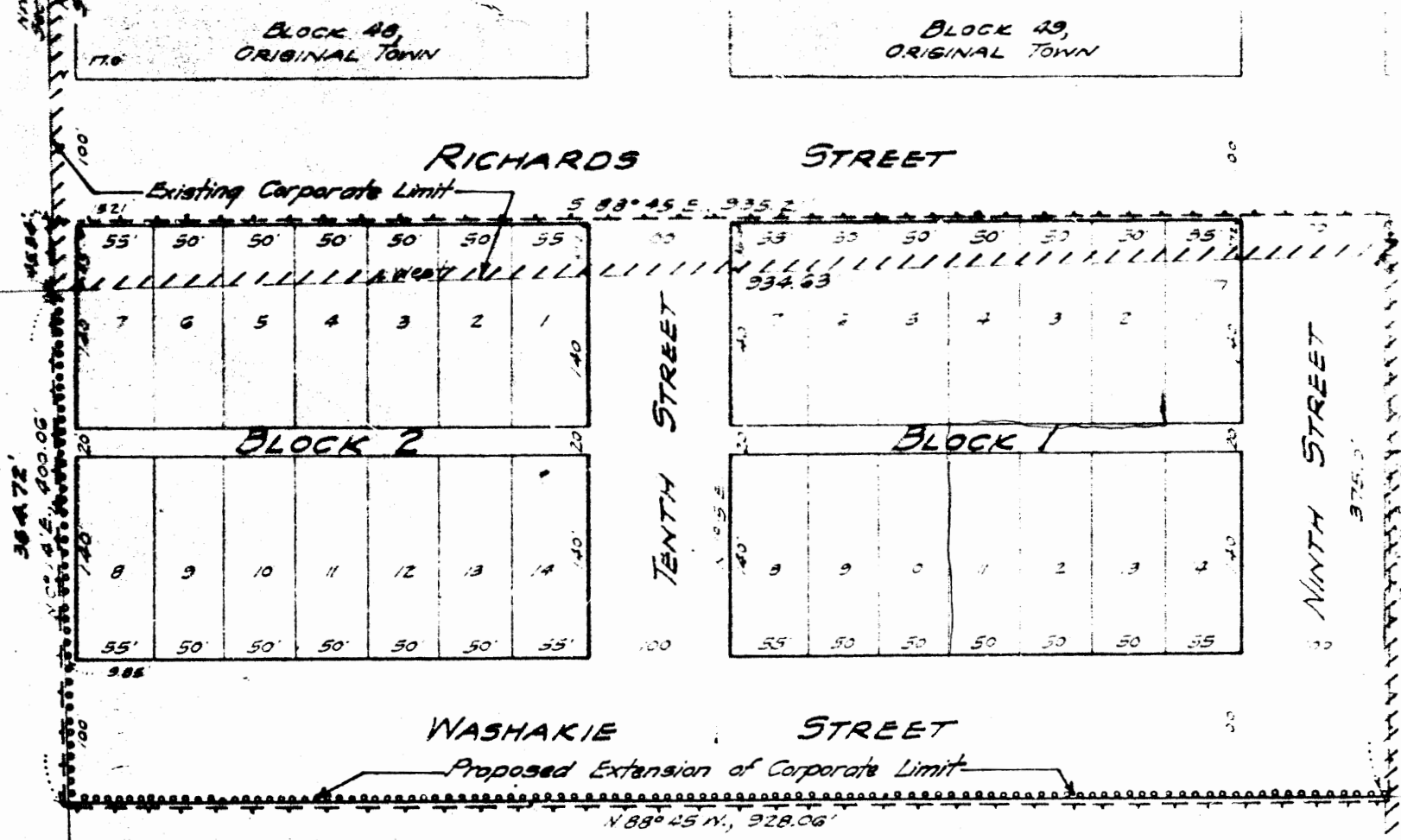

CERTIFICATE OF DEDICATION

This certifies that Harry L. Estes and Mildred A. Estes are the owners of the parcel of land shown on this plat as Blocks 1 and 2, of the Canyon View Addition to the Town of Thermopola, Wyoming, said parcel of land being a part of the NE 1/4 NE 1/4 and Lot 1, Section 2, T. 42N., R. 95W., the boundary of said parcel of land being described as follows: Beginning at the northwest corner of Block 9 of Brydon's Third Addition to the Town of Thermopola, Wyoming; thence $S 1^{\circ} 15' W$, along the west line of said Block 9, and along said west line produced, for a distance of 400.0 feet; thence $N 88^{\circ} 45' W$, 928.06 feet; thence $N 0^{\circ} 14' E$, 400.06 feet along the west line of Lot 1 and along the west line of the NE 1/4 NE 1/4 Section 2, T. 42N., R. 95W., to the south line of Richards Street; thence $S 88^{\circ} 45' E$, 935.21 feet along the south line of Richards Street to the point of beginning; that the owners have caused said land to be platted as Blocks 1 and 2 of the Canyon View Addition, as is shown by this plat and Surveyor's Certificate; that the streets and alleys as shown within the boundary of said Addition are hereby dedicated to the public use.
