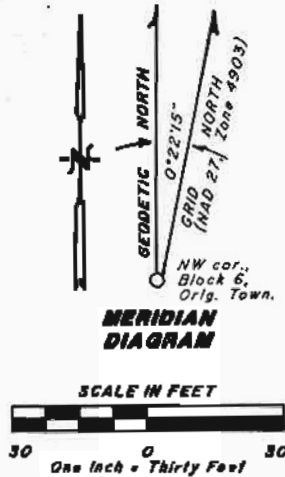

- Basis of Bearing - The geodetic meridian computed at the northwest corner of Block 6 at the Original Townsite. See Meridian Diagram for particulars.
- Retracement survey performed using conventional "total station" instrumentation and random traverse methodology to tribrach and bipod mounted reflectors. Positional accuracy falls within the limits set forth by current standards for ALTA / ACSM Land Title Surveys.
- This plat has been prepared, executed, approved and recorded to conform to the requirements of Town of Thermopolis Ordinance No. 801, adopted 17 Jul. 2007. More specifically, to accommodate the construction of a duplex without finwalls as per RC 2006 Sec. 317.

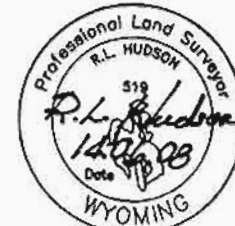
