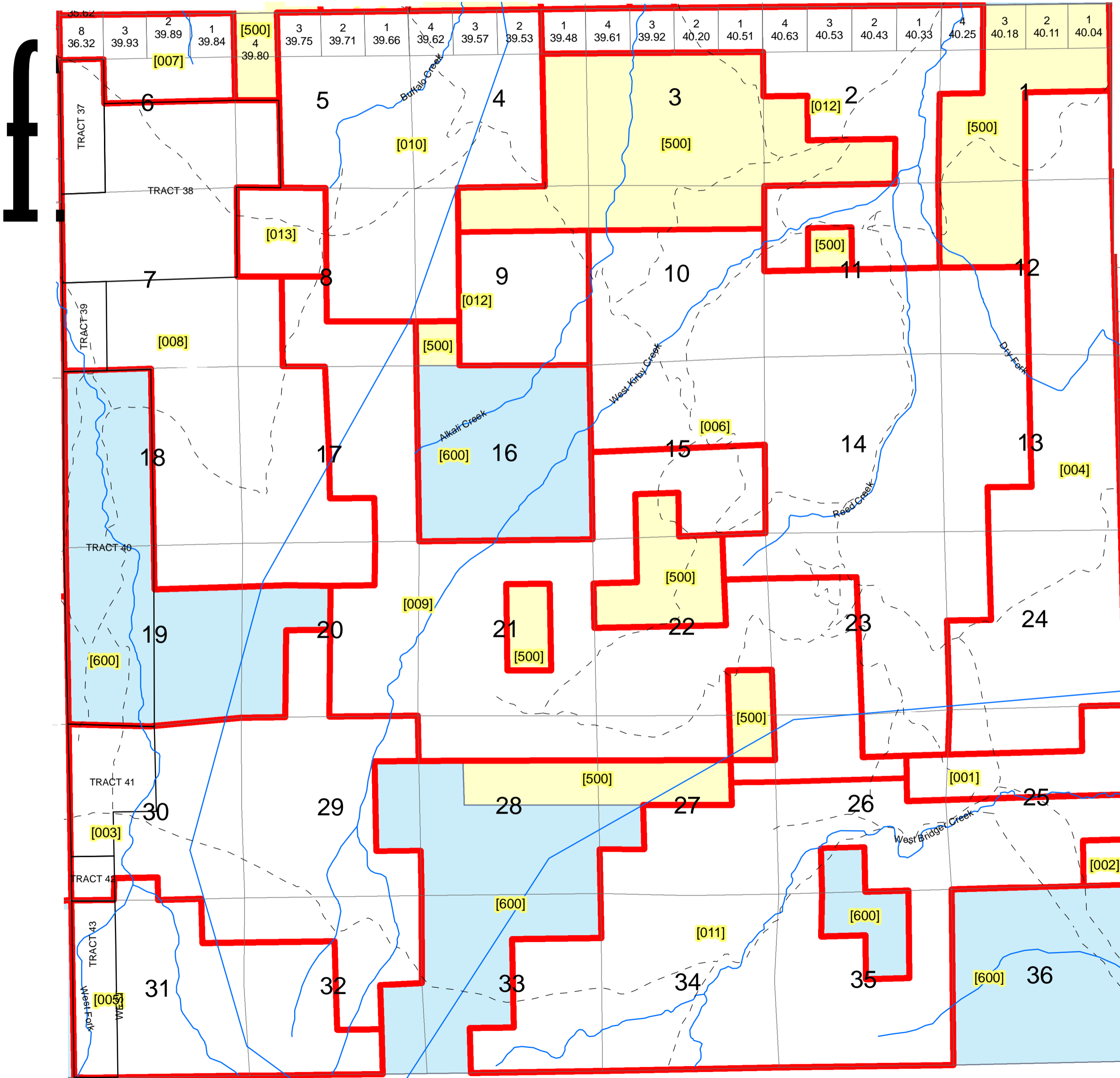
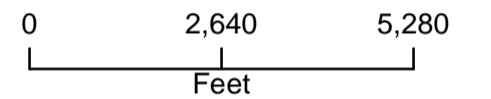


TOWNSHIP 41 NORTH, RANGE 92 WEST, 6TH P.M.
