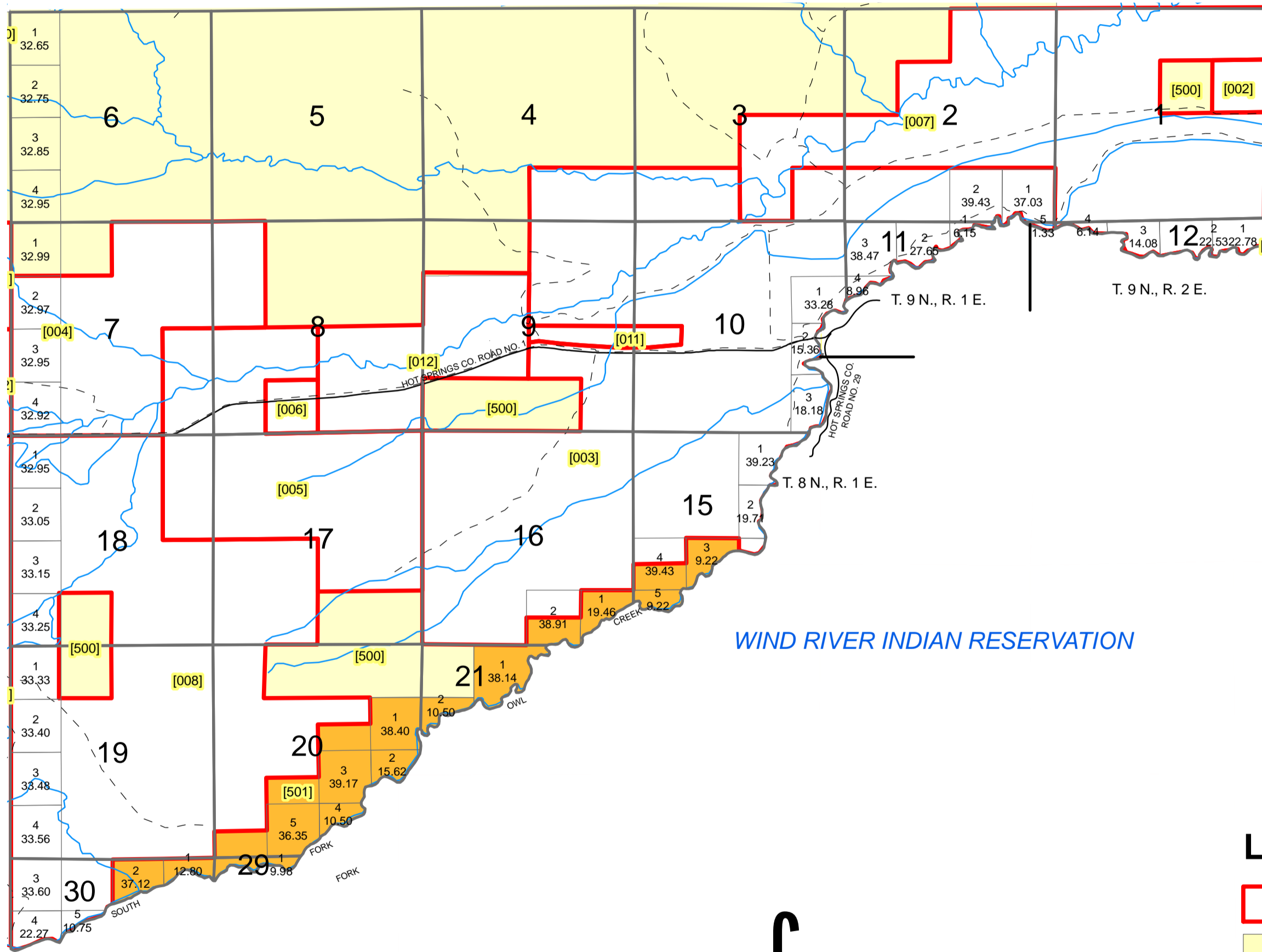
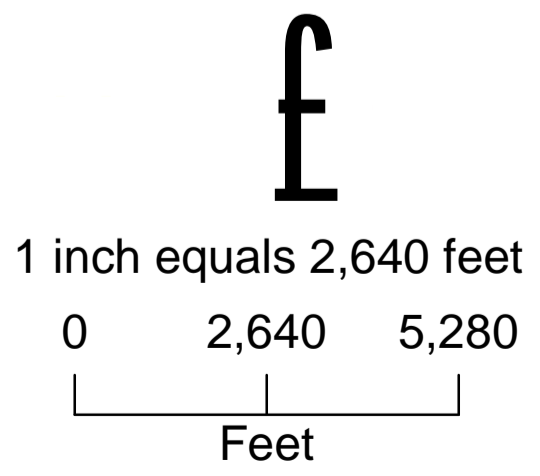


# TOWNSHIP 43 NORTH, RANGE 99 WEST, 6TH P.M. HOT SPRINGS COUNTY, WYOMING
